Transformation in 5 Years

Work within the TRAM network to develop culturally sensitive diagnostic screening and assessment tools for Indigenous adolescents.

Identification and study of Indigenous community-based "best practices" in adolescent mental health, intellectual disabilities, and addictions in rural, remote, urban, reserve and non-reserve settings.

Bridging Indigenous knowledge and Western science by developing an "ethical space" where TRAM researchers; Indigenous health care leaders, front line workers, youth stakeholders; and government policy and decision makers can transform clinical, addiction, and public health to improve the mental health of Indigenous youth.
